

Good afternoon Pam,

Thank you for working with Frank on this. He is wonderful on the roads. I have attached the supporting documentation for Highway 35.

He has asked that I send the following statement for Jerusalem Hill TH 27 to confirm the milage:

In the Town of Rochester, Town Highway #2 Jerusalem Hill Rd. is being maintained as a Class 3 town road. A section of this road has been mapped as a Class 3 Road that intersects with a Private Drive to the right, Rocky Road.

The town has maintained the portion after the intersection of Rocky Road to Class 3 standards for 2,254' or .427 miles, replacing culverts, graveling, etc. for many years. Winter maintenance is also provided for this section. The

road continues after that where it changes classification to a public trail.

This section has been classified as a Class 3 NUTS Road on our highway maps and should be considered as a Class 3 adding to the length of Town Highway #27. The milage difference between Class 3 and Class 3 NUTS is .063 will remain as a Class 3 NUTS to the intersection with Town legal trail #3.


Hi Julie and Joan,

We are trying to nail down the accurate location of the end of TH-35 (State Garage Rd) and the beginning of the National Forest Highway in Rochester. In the last Town Highway Map (below), we mapped it out at the current mileage of 0.61, but we are thinking that TH-35 may extend further. In 2018, we mapped it past the curve in the road to the south more, but does it extend all the way to the driveway of House #700 as shown on the E911 Map Viewer


below? You can see in this E911 Map image that the Town ROW parcel also extends to this location.

Can you please confirm the location of the end of TH-35 for us? If it extends to House #700, this may reflect a mileage increase for this road and we can include it in the Mileage Certificate for 2022.
