Happy New Year Kerry-

Victoria passed your request across the hall to my office. I'm glad to help, because I'm hoping you can also help me with a correction I have tried to make several times a few years back.

About a year ago, I noticed GOOGLE MAPS had labeled a private Driveway as ARCTIC CAT LANE (which currently is labeled by Google as TH 97).

I did a correction request, which they did confirm and update.

So, you are correct in thinking that TH97 should be updated as well. Thanks for taking care of this on your end. As for Alcorn Rd, yes, it is one and the same. Alcorn was the person who did the subdivision. Glad I just lightened up your workload, because I would like to fill it with another correction.

I've also attached two VT Parcel Maps that have an incorrect road name of DRAGON RD. Any idea how to clear these up?

I have also attached a VTe911 map to show you this is correct, and the standard all maps should comply with, from what I understand.

Now for my dilemma and request:

The Town Hwy maps have the correct location of TH43- Putt RD, Class 3, but the Class 4 is totally wrong. A couple years ago I sent in documentation showing that there is clear evidence by surveys and existing road with stone walls and unlogged trees along this part of the class 4 Rd. It does connect to the North Rd, but much further South.

As depicted on the current TH maps, it would have to go right through an established stone wall that is the boundary line between those two parcels.

There is also no evidence on the ground to indicate there ever was a road there.

Maybe you can either help us out or get me to the right department that can.

Thank you for returning my call yesterday. Now that I know that Arctic Cat Rd is public, I would like add it to the Royalton Town Highway Map.


Before going into details about the documentation we would need to add a new road to the map, I think it is possible that VTrans is mapping TH-97 incorrectly (see the first image showing TH-97 below). The second image below is from Google Maps and shows both Arctic Cat Rd and a driveway just west of it, where VTrans currently maps TH-97. Can you confirm for me whether or not Arctic Cat Rd used to be called Alcorn Rd? Alcorn Rd is the name provided on the 1985 Mileage Certificate when TH-97 was added to our records)? If so, then I have all the information and documentation I need and will update the Royalton Town Highway map to show TH-97 as Arctic Cat Rd in the correct location. If Alcorn Rd was

something other than Arctic Cat Rd, then we'll have a little more work ahead of us to make sure our records are correct.


