

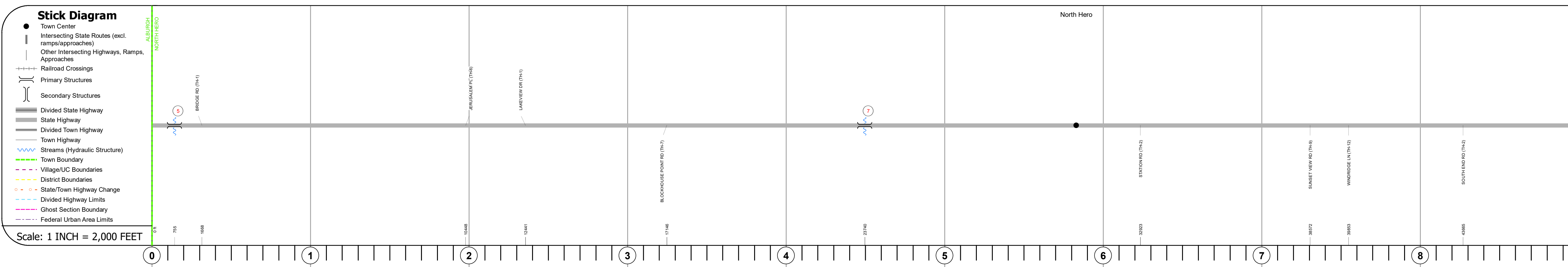
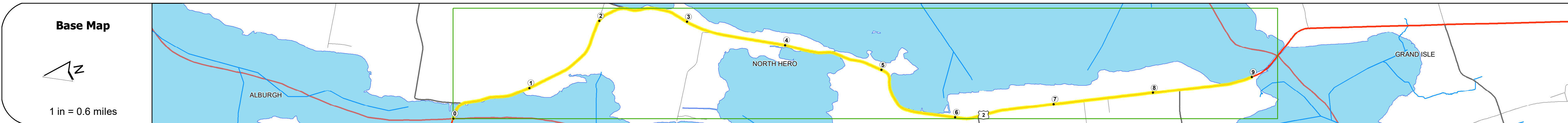
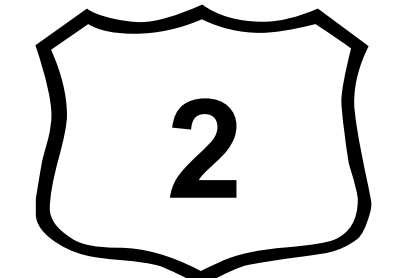
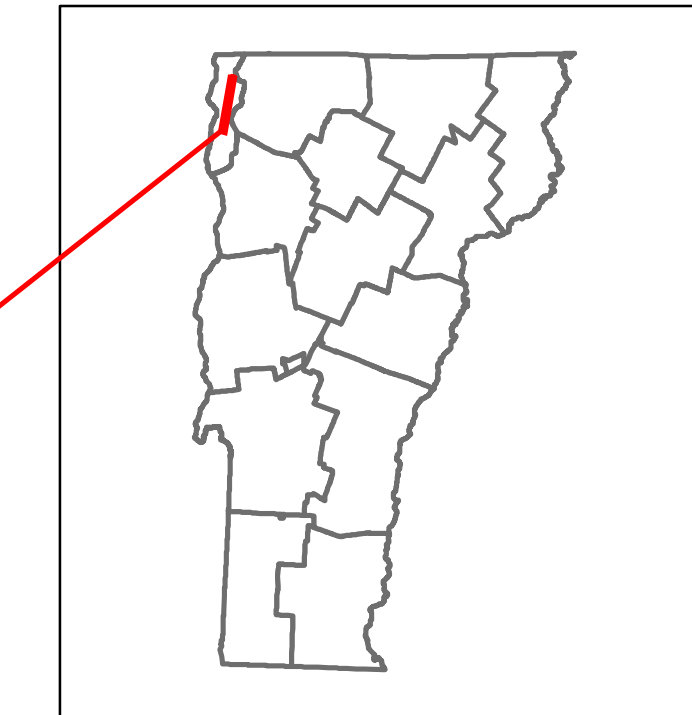


Route Log and Progress Chart
