### 19 V.S.A. § 305. Measurement and inspection

#### § 305. Measurement and inspection

- (a) After reasonable notice to the selectboard, a representative of the agency may measure and inspect the class 1, 2, and 3 town highways in each town to verify the accuracy of the records on file with the agency. Upon request, the selectboard or their designee shall be permitted to accompany the representative of the agency during the measurement and inspection. The agency shall notify the town when any highway, or portion of a highway, does not meet the standards for its assigned class. If the town fails, within one year, to restore the highway or portion of the highway to the accepted standard, or to reclassify, or to discontinue, or develop an acceptable schedule for restoring to the accepted standards, the agency for purposes of apportionment under section 306 of this title shall deduct the affected mileage from that assigned to the town for the particular class of the road in question.
- (b) Annually, on or before February 10, the selectboard shall file with the town clerk a sworn statement of the description and measurements of all class 1, 2, 3, and 4 town highways and trails then in existence, including any special designation such as a throughway or scenic highway. When class 1, 2, 3, or 4 town highways, trails, or unidentified corridors are accepted, discontinued, or reclassified, a copy of the proceedings shall be filed in the town clerk's office and a copy shall be forwarded to the agency.
- (c) All class 1, 2, 3, and 4 town highways and trails shall appear on the town highway maps by July 1, 2015.
- (d) At least 45 days prior to first including a town highway or trail that is not clearly observable by physical evidence of its use as a highway or trail and that is legally established prior to February 10, 2006 in the sworn statement required under subsection (b) of this section, the legislative body of the municipality shall provide written notice and an opportunity to be heard at a duly warned meeting of the legislative body to persons owning lands through which a highway or trail passes or abuts.
- (e) The agency shall not accept any change in mileage until the records required to be filed in the town clerk's office by this section are received by the agency. A request by a municipality to the agency for a change in mileage shall include a description of the affected highway or trail, a copy of any surveys of the affected highway or trail, minutes of meetings at which the legislative body took action with respect to the changes, and a current town highway map with the requested deletions and additions sketched on it. A survey shall not be required for class 4 town highways that are legally established prior to February 10, 2006. All records filed with the agency are subject to verification in accordance with subsection (a) of this section.
- (f) The selectboard of any town who are aggrieved by a finding of the agency concerning the measurement, description or classification of a town highway may appeal to the transportation board by filing a notice of appeal with the executive secretary of the transportation board.
- (g) The agency shall provide each town with a map of all of the highways in that town together with the mileage of each class 1, 2, 3, and 4 highway, as well as each trail, and such other information as the agency deems appropriate.

#### RESOLUTION

To add certain class 4 town highways to the town highway map and the sworn statement of the description and measurement of all class 1, 2, 3 and 4 town highways in the Town of Barnard.

Whereas, the Select Board of the Town of Barnard did on November 18, 2009 sign a Notice of Select Board Meeting and opportunity to be heard regarding the addition of 43 unmapped class 4 town highways to the town highway map and sworn statement of the description and measurement of all class 1, 2, 3 and 4 town highways in the Town of Barnard; and

Whereas, the Select Board did on November 19, 2009 post a copy of the notice and opportunity to be heard inside the office of the Barnard Town Clerk, on the bulletin board outside the office of the Barnard Town Clerk, on the bulletin board outside the Barnard General Store, and on the bulletin board inside the Barnard Post Office; and

Whereas, the Select Board did publish the notice and opportunity to be heard in the November 20, 2009 edition of the *Valley News* newspaper; and

Whereas, the Select Board did on November 21, 2009 mail a copy of the notice and opportunity to be heard to the persons owning land through which the these unmapped town highways pass or abut; and

Whereas, the Select Board did meet on December 9, 2009 and conduct a public meeting, continued to December 16, 2009, and did hear testimony on the subject of adding these unmapped town highways to the town highway map; and

Whereas, the Select Board did announce at the public meeting and through an article in the January 2010 issue of *The Barnard Bulletin* newsletter and by other means that written comments would be accepted up to January 10, 2010 and would finalize a decision on or around January 20, 2010; and

Whereas, the Select Board has given due consideration to the comments received; now, therefore,

Be It Resolved that the Select Board hereby votes to add the following 37 class 4 town highways to the town highway map and to the sworn statement of the description and measurement of all class 1, 2, 3 and 4 town highways in existence in the Town of Barnard, said sworn statement to be filed with the Barnard Town Clerk and the Vermont Agency of Transportation on or before February 10, 2010:

The following class 4 town highways are identified through a numbering system developed by the Barnard Class 4 Roads Advisory Committee (hereinafter abbreviated "BRC") and depicted on a map signed by the Select Board on even date with this Resolution.

BRC-101 extends from TH-73 northeasterly to Gulf Road.

BRC-102 extends from TH-60 southerly to Lakota Road.

BRC-103 extends from Lakota Road southerly to the Bridgewater Town Line.

BRC-104 extends from Lakota Road westerly to BRC-105.

BRC-105 extends from Morgan Road southerly to the Bridgewater Town Line.

BRC-107 extends from Barlow Road northeasterly to Bennett Road.

BRC-108 extends from West Road southwesterly to Chateauguay Road.

BRC-111 extends from TH-48 westerly to the Stockbridge Town Line.

BRC-115 extends from BRC-111 northerly to BRC-118.

BRC-118 extends from the Stockbridge Town Line easterly to Smith Hill Road.

BRC-119 extends from TH-45 southerly to BRC-111.

- BRC-120 extends from BRC-118 southeasterly to BRC-119.
- BRC-122 extends from TH-43 westerly to BRC-120.
- BRC-123 extends from TH-44 southwesterly to TH-43.
- BRC-126 extends from Mt. Hunger Road southerly to Smith Hill Road.
- BRC-128 extends from Smith Hill Road northwesterly to the Stockbridge Town Line.
- BRC-129 extends from BRC-128 southwesterly to the Stockbridge Town Line.
- BRC-133 extends from Masterson Road southwesterly to Old Mt. Hunger Road.
- BRC-136 extends from BRC-108 southeasterly to BRC-107.

- BRC-207 extends from VT Route 12 easterly approximately 0.3 miles to the right-of-way as agreed on by the Town of Barnard and Gary and Janet Robison.
- BRC-208 extends from the right-of-way conveyed to the Town of Barnard by David and Sophia Stone on September 8, 2006 southeasterly approximately 0.7 miles to Eastman Road.
- BRC-212 extends from Lime Pond Road easterly 0.43 miles to the former dwelling of Laurence Cooty.
- BRC-213 extends from Lime Pond Road easterly 0.75 miles to the former dwelling of Abner Buckman.
- BRC-215 extends from Sayer Road easterly to BRC-217.
- BRC-217 extends from Ashley Road northerly to Walker Hill Road.
- BRC-218 extends from Walker Hill Road easterly to the Pomfret Town Line.
- BRC-219 extends from TH-32 easterly to Walker Hill Road.
- BRC-223 extends from Ellis Farm Road northwesterly to the Royalton Town Line.
- BRC-224 extends from Levasseur Road northwesterly to BRC-225.
- BRC-225 extends from TH-17 northeasterly to the Royalton Town Line.
